

**ORDINANCE NO. 106-2004**

**HONEY BROOK TOWNSHIP  
CHESTER COUNTY, PENNSYLVANIA**

**AN ORDINANCE ADOPTED PURSUANT TO SECTION 4902 OF THE  
PENNSYLVANIA MOTOR VEHICLE CODE, 75 PA.C.S.A., RESTRICTING  
TRUCK TRAFFIC TO LOCAL DELIVERY ONLY AS FOLLOWS:**

**BE IT HEREBY ENACTED AND ORDAINED** by the authority of the Board of Supervisors of Honey Brook Township, in accordance with the authority granted to the Township by Section 4902 and Section 6109 of the Pennsylvania Motor Vehicle Code, 75 Pa.C.S.A. §4902 and 75 Pa.C.S.A. §6109, as follows:

**SECTION 1.** In accordance with a traffic study prepared by Richard J. Craig, P.E., and submitted to the Township on or about September 4, 2003 the Board does hereby find:

- a. The Study submitted to the Township constitutes an "engineering and traffic investigation" as required by Sections 4902(a), 4902(f) and 6109(e), for Todd Road (T-499) between Horseshoe Pike (SR0322) and Twin County Road (SR0010).
- b. Pursuant to such investigation, the Board determines that the construction and width of the road is less than what is reasonable and safe to allow commercial vehicles over 26,000 pounds GVWR to use the road as a through street.
- c. The Board establishes a restriction on commercial vehicles over 26,000 pounds GVWR to local deliveries only.

**SECTION 2.** In accordance with a traffic study prepared by Richard J. Craig, P.E., and submitted to the Township on or about September 4, 2003 the Board does hereby find:

- a. The Study submitted to the Township constitutes an "engineering and traffic investigation" as required by Sections 4902(a), 4902(f) and 6109(e), for Grieson Road (T-339) between Cupola Road (T-376) and Chestnut Tree Road (SR4025).
- b. Pursuant to such investigation, the Board determines that the construction and width of the road is less than what is reasonable and safe to allow commercial vehicles over 26,000 pounds GVWR to use the road as a through street.
- c. The Board establishes a restriction on commercial vehicles over 26,000 pounds GVWR to local deliveries only.

**SECTION 3.** In accordance with a traffic study prepared by Richard J. Craig, P.E., and submitted to the Township on or about September 4, 2003 the Board does hereby find:

- a. The Study submitted to the Township constitutes an "engineering and traffic investigation" as required by Sections 4902(a), 4902(f) and 6109(e), for Cupola Road (T-376) between Horseshoe Pike (SR0322) and Chestnut Tree Road (SR4025).

- b. Pursuant to such investigation, the Board determines that the construction and width of the road is less than what is reasonable and safe to allow commercial vehicles over 26,000 pounds GVWR to use the road as a through street.
- c. The Board establishes a restriction on commercial vehicles over 26,000 pounds GVWR to local deliveries only.






