RESOLUTION 2-2002
HONEY BROOK TOWNSHIP

WHEREAS, the Township of Honey Brook (the "Township") has previously created an Agricultural Security Area as authorized under Act 43 (the "Act") of the Statutes of the Commonwealth of Pennsylvania, and
WHEREAS, the Township receives applications from interested landowners to add to or modify the Agricultural Security Area between statutory review periods by including their properties, and
WHEREAS, the Act deems a property included the Agricultural Security Area one-hundred eighty (180) days from the date of the application, unless the Township takes official action prior to the end of the review period, and
WHEREAS, the Township has received applications on the dates specified to modify the Agricultural Security Area by adding the following properties:

- Joseph & Joanne Guiseppe, 95 Three Joes Lane, TPN 22-10-35, containing 61.6 acres more or less, on May 1, 2001
- Gideon E. Stoltzfus, Jr. & Rose Marie Stoltzfus, 330 Todd Road, TPN 22-4-3 & 22-4-66, containing 59.8 acres more or less, and 34.5 acres more or less, on May 1, 2001
- Gideon L. Stoltzfus & Lavina B. Stoltzfus, 969 Park Road, TPN 22-10-9, containing 160.702 acres, more or less, on May 1, 2001
- Steven R. Yoder & Aary Mae Yoder, 1273 Beaver Dam Road, TPN 22-10-9.1, containing 25 acres more or less, on August 13, 2001

WHEREAS, the Township has taken no official action on these applications prior to expiration of the one-hundred eighty (180) day review period,
THEREFORE, BE IT HEREBY RESOLVED the Board of Supervisors of Honey Brook Township deems these properties to be included in the Honey Brook Township Agricultural Security Area as required under the Act, and directs the Township Secretary to take appropriate action to record the inclusion of these properties with the Recorder of Deeds.


