WHEREAS, the developer has posted an appropriate maintenance bond to guarantee the structural integrity of the construction for a period of eighteen (18) months, and


WHEREAS, the Township Engineer has inspected the construction of road and found it to be satisfactory, and


WHEREAS, the Board of Supervisors has determined the name of the street shall be Southwind Drive,


BE IT THEREFORE RESOLVED, by the Board of Supervisors of Honey Brook Township, to accept dedication and declare open for public use, Southwind Drive.





