

# Honey Brook Township

ORDINANCE NO. 77 of 1997

## AN ORDINANCE OF THE TOWNSHIP OF HONEY AMENDING ORDINANCE 43 OF 1991 DEALING WITH PUBLIC WATER SUPPLY IN CERTAIN SECTIONS OF THE TOWNSHIP

**BE IT HEREBY ENACTED AND IT IS HEREBY ENACTED** by the Board of Supervisors of Honey Brook Township that Ordinance 43 of 1991 is hereby amended in the following respects:

**Section 1.** General Policy is hereby amended by adding an additional sentence at the end thereof as follows:

"In addition to the properties listed on Exhibit "A" and in addition to the other properties shown on Exhibit "B" within close proximity to the proposed water line, if there are other dwellings or land uses requiring water which are adjacent to or nearby existing water mains, such properties must be connected to the public water supply and included within the terms of this Ordinance if such connection is determined to be appropriate by the Honey Brook Borough Authority or a successor authority or other municipal organization whose purpose is to administer the public water system."

**Section 2.** Prohibited Acts is hereby amended by adding an additional provision as follows:

"When any property has been connected to public water supply, it shall be unlawful for the property owner or anyone on the property owner's behalf to disconnect the property from the public water supply or otherwise cease the use of public water for any purpose unless permitted in writing by the Honey Brook Borough Authority or a successor authority or other municipal organization whose purpose is to administer the public water system and the Honey Brook Township Board of Supervisors."

**Section 3.** Violations is hereby amended by adding an additional provision as follows:

"When the Township takes appropriate enforcement action as permitted under Ordinance 43 of 1991 and/or Ordinance 74 of 1997 and/or appropriate civil enforcement proceedings as permitted by 71 A of 1996, the Township may be reimbursed its expenses for doing same by the Borough of Honey Brook, the Honey Brook Borough Authority, or a successor authority or other municipal organization whose purpose is to administer the public water system."


Any provisions of any rules and regulations or ordinances inconsistent herewith are hereby repealed. Should any section hereof, or any section of Ordinance No. 43 of 1991 be determined to be unenforceable, illegal or unconstitutional, or otherwise defective, then the provisions of this Ordinance and Ordinance No. 43 of 1991 are declared to be severable, and such defective section shall be considered to have been deleted from the remaining provisions of this Ordinance and Ordinance No. 43 and its amendments, and the remaining provisions shall be read together as if the defective provision were not included nor intended to be included by the Board of Supervisors.
