ORDINANCE NO. 87, 1998

AN ORDINANCE ADOPTED PURSUANT TO SECTION 3363 OF THE PENNSYLVANIA VEHICLE CODE, 75 Pa.C.S.A. §3363, ALTERING MAXIMUM SPEED LIMITS ON PORTIONS OF MOUNT PLEASANT ROAD AND CUPOLA ROAD IN HONEY BROOK TOWNSHIP.

BE IT HEREBY ENACTED AND ORDAINED by the authority of the Board of Supervisors of Honey Brook Township, in accordance with the authority granted to the Township by Section 3363 of the Pennsylvania Vehicle Code, 75 Pa.C.S.A. §3363, as follows:

1. In accordance with the "Speed Restrictions Study and Data Sheets" prepared by Richard J. Craig, P.E., and submitted to the Township on or about June 6, 1998, the Board does hereby find:

a. The Study submitted to the Township constitutes an "engineering and traffic investigation" as required by Section 3363.

b. Pursuant to such investigation, the Board determines that the maximum speed permitted by the Vehicle Code is greater than is reasonable and safe under the conditions found to exist on Mount Pleasant Road from its intersection with SR10 to the Township line.

c. The Board establishes a reasonable and safe limit of 35 miles per hour on the aforesaid section of Mount Pleasant Road.

2. In accordance with the "Speed Restrictions Study and Data Sheets" prepared by Richard J. Craig, P.E., and submitted to the Township on or about June 8, 1998, the Board does hereby find:

a. The Study submitted to the Township constitutes an "engineering and traffic investigation" as required by Section 3363.


b. Pursuant to such investigation, the Board determines that the maximum speed permitted by the Vehicle Code is greater than is reasonable and safe under the conditions found to exist on Cupola Road from its intersection with SR322 to Chestnut Tree Road.

c. The Board establishes a reasonable and safe limit of 35 miles per hour on the aforesaid section of Cupola Road.




