MODIFICATION TO AGRICULTURAL SECURITY AREA

The Board of Supervisors of Honey Brook Township pursuant to applications made and after review by the Chester County Planning Commission, the Honey Brook Township Planning Commission and the Honey Brook Township Agricultural Security Area Board do hereby agree to modify the Agricultural Security Area of Honey Brook Township and to include within the Agricultural Security Area the Following properties:

Property of David and Roberta Rotelle being Tax Map
Parcel 22-06-0021.0100 consisting of 26.63 acres and
Tax Map Parcel 22-06-0004.0200 consisting of 55.7 acres;
And

Property of Paul W. and Jean M. Dovin being Tax Map
Parcel 22-07-0092.01A0 containing 29.2 acres and Tax
Map Parcel 22-07-0092.0200 consisting of .488 acres.


This Modification was approved following hearing held April 12, 2000 and meeting of same date to accept the above-described properties into the Honey Brook Township Agricultural Security Area.
