The Area adopted, as proposed, contains 6,895 acres situate in Chester County and 88 acres in Lancaster County.

Isaac Hoover 10F-4-9 69.3 acres


Mildred Hoover 10F-2-14 3.4 acres

Said property being both in Honey Brook Township, Chester County and Salisbury Township, Lancaster County.


