RESOLUTION NO. 2016- 21

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF HONEY BROOK
TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AUTHORIZING A
TRANSFER OF \$85,343.78 FROM THE ESCROW FUND TO THE
GENERAL FUND**

WHEREAS, the Second Class Township Code, Section 3202(f) authorizes the board of supervisors by resolution to transfer unencumbered moneys from one township account to another; and

WHEREAS, the Board of Supervisors of Honey Brook Township (the "Board") has become aware of certain funds remaining in the Township Escrow Account attributable to land development projects long ago completed, for which the respective developers have not requested any return of funds; and

WHEREAS, upon investigation, the Board reasons that expenses sufficient to eliminate the escrow funds allocable to the respective projects were improperly paid from the Township's General Fund by previous boards of supervisors and never reimbursed from the respective escrow accounts; and

WHEREAS, the Board has deemed it appropriate to, therefore, transfer such funds from the Escrow Fund to the General Fund;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Honey Brook Township, Chester County, Pennsylvania that there shall be a transfer to General Fund; specifically, the Treasurer is authorized to transfer (\$85,343.78) from the Escrow Fund, budgetary account number 8891046, to the General Fund, budgetary account number 8891020.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Honey Brook Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.

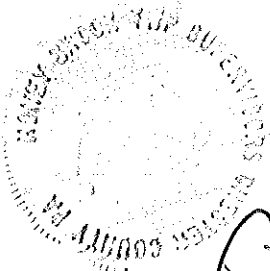
FURTHER RESOLVED, that this Resolution shall become effective immediately.
