## RESOLUTION NO. 2016-24

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF HONEY BROOK, CHESTER COUNTY, PENNSYLVANIA, FIXING THE TAX RATE LEVIED ON ALL REAL PROPERTY WITHIN THE TOWNSHIP FOR THE CALENDAR YEAR 2017.

WHEREAS, pursuant to Section 3205(a) of the Second Class Township Code, the board of supervisors shall annually adopt a resolution to set the real estate tax rate.

BE IT RESOLVED AND ENACTED, by the Board of Supervisors of the Township of Honey Brook that a tax be and the same is hereby levied on all real property within the Township of Honey Brook subject to taxation for the fiscal year 2017, as follows:

Tax rate for general purposes, the sum of 0.98 mills on each dollar of assessed valuation, or the sum of .098 cents on each one hundred dollars of assessed valuation.
