RESOLUTION NO. 2017- 6

A RESOLUTION OF THE BOARD OF SUPERVISORS OF HONEY BROOK TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, AUTHORIZING THE PURCHASE THROUGH COSTARS OF A 2018 MACK CAB AND CHASSIS FROM THE PENNSYLVANIA TRUCK CENTER AND A DUMP BODY, SNOW PLOW AND SPREADER FROM E.M. KUTZ, INC.

WHEREAS, Honey Brook Township is a Second Class Township in the Commonwealth of Pennsylvania; and

WHEREAS, as a Second Class Township, Honey Brook Township is governed by the Pennsylvania Second Class Township Code; and

WHEREAS, Section 1502 of the Second Class Township Code, 53 P.S. § 66502, provides for purchases deemed to be in the best interest of the Township by the Board of Supervisors; and

WHEREAS, the Honey Brook Township Board of Supervisors approved a resolution enabling the Township to participate in the Commonwealth Procurement Cooperative Purchasing Program; and

WHEREAS, the Commonwealth Procurement Cooperative Purchasing Program is commonly referred to as COSTARS; and

WHEREAS, purchases through COSTARS satisfies the requirements for bids for purchases of equipment provided for in Article XXXI of the Second Class Township Code, 53 P.S. §68101 - §68109; and

WHEREAS, the Township has identified the need to purchase a new truck cab and chassis for utilization by the Public Works Department; and

WHEREAS, the Township's Public Works Director has evaluated a variety of truck cabs and chassis for public works and has determined that the required needs will best be met by purchasing a 2018 Mack Cab and Chassis as specified on the spec sheet made a part hereof and attached hereto as Exhibit "A"; and

WHEREAS, Pennsylvania Truck Center can provide the new cab and chassis under a Commonwealth Cooperative Purchasing Program, COSTARS; and

WHEREAS, pursuant to the Commonwealth Cooperative Purchasing Program, COSTARS, the Township can purchase the 2017 Mack Cab and Chassis specified on Exhibit "A" from Pennsylvania Truck Center in the amount of \$123,879.40; and

WHEREAS, the Township has identified the need to purchase a dump body, snow plow and spreader for attachment to the new Mack Cab and Chassis for public works utilization; and

WHEREAS, the Township's Public Works Director has evaluated a variety of dump bodies, snow plows and spreaders for public works; and

WHEREAS, E.M. Kutz, Inc. can provide the new dump body, snow plow and spreader as specified on the spec sheet made a part hereof and attached hereto as Exhibit "B" to attach to the 2018 Mack Cab and Chassis under a Commonwealth Cooperative Purchasing Program, COSTARS; and

WHEREAS, pursuant to the Commonwealth Cooperative Purchasing Program, COSTARS, the Township can purchase the dump body, snow plow and spreader specified on Exhibit "B" from E.M. Kutz, Inc. in the amount of \$86,954.00; and

WHEREAS, the Board of Supervisors has approved the purchase of this equipment in the 2017 Budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Honey Brook Township that the Township Manager is authorized to purchase through the Commonwealth Cooperative Purchasing Program, COSTARS, a 2018 Mack Cab and Chassis specified in Exhibit "A" from Pennsylvania Truck Center in the amount of \$123,879.40 and 2.) a dump body, snow plow and spreader specified in Exhibit "B" from E.M. Kutz, Inc. in the amount of \$86,954.00.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of the Township of Honey Brook that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.


FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.


FURTHER RESOLVED, that this Resolution shall become effective immediately or as soon as legally permissible.

RESOLVED, by the Board of Supervisors of Honey Brook Township, Chester County, Pennsylvania this 8th day of February, 2017.




