**RESOLUTION NO. 2018 - 13**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF HONEY BROOK TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, AUTHORIZING THE AWARD OF A CONSTRUCTION CONTRACT TO ROCKY CREEK BUILDERS.**

WHEREAS, Honey Brook Township is a Second Class Township in the Commonwealth of Pennsylvania; and

WHEREAS, as a Second Class Township, Honey Brook Township is governed by the Pennsylvania Second Class Township Code; and

WHEREAS, Section 3101 of the Second Class Township Code authorizes the Township to make contracts for purchases under this act; and

WHEREAS, the Township has identified the need to construct a shed to store public works equipment; and

WHEREAS, the Township's Public Works Director has solicited proposals to construct the shed; and

WHEREAS, three (3) telephonic proposals were received by the Public Works Director, Don Johnson on or before the July 19, 2018 deadline; and

WHEREAS, the proposals received are:

Rocky Creek Builders, Omar Stoltzfus	5676 Seldomridge Road, Narvon PA	\$13,600

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Honey Brook Township that the Township Manager is authorized to award a contract for the construction of a shed to the low bidder, Rocky Creek Builders.




FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.


FURTHER RESOLVED, that this Resolution shall become effective immediately or as soon as legally permissible.


