

**HONEY BROOK TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA**

**RESOLUTION NO. 2018-15**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF HONEY BROOK, CHESTER COUNTY, PENNSYLVANIA, FIXING THE TAX RATE LEVIED ON ALL REAL PROPERTY WITHIN THE TOWNSHIP FOR THE CALENDAR YEAR 2019.**

WHEREAS, pursuant to Section 3205(a) of the Second Class Township Code, the Board of Supervisors shall annually adopt a resolution to set the real estate tax rate.

BE IT RESOLVED AND ENACTED, by the Board of Supervisors of the Township of Honey Brook that a tax be and the same is hereby levied on all real property within the Township of Honey Brook subject to taxation for the fiscal year 2019, as follows:

Tax rate for general purposes, the sum of 0.98 mills on each dollar of assessed valuation, or the sum of .098 cents on each one hundred dollars of assessed valuation.

The same being summarized in tabular form as follows:

<u>Tax</u>	<u>Mills on Each Dollar of Assessed Valuation</u>	<u>Cents on Each One Hundred Dollars of Assessed Valuation</u>
General Purpose	0.98 Mills	0.098 cents

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Honey Brook Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part not been included herein.

FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.

FURTHER RESOLVED, that this Resolution shall be effective immediately.


