**RESOLUTION NO. 2019- 3**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF HONEY BROOK TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, APPOINTING DAVID RODGERS AND DARLENE OLEAR AS AN ALTERNATE TO THE ZONING HEARING BOARD OF HONEY BROOK TOWNSHIP**

WHEREAS, pursuant to the Pennsylvania Municipalities Planning Code, Section 903, 53 P.S. §10903, the Board of Supervisors shall appoint residents of the municipality to the Zoning Hearing Board by Resolution; and

WHEREAS, per Section 903(b) of the Pennsylvania Municipalities Planning Code, 53 P.S. §10903(b), the Board of Supervisors may by Resolution appoint residents of the municipality to serve as alternate members to the Zoning Hearing Board; and

WHEREAS, the Board of Supervisors of Honey Brook Township intends to appoint David Rodgers as a member and Darlene Olear as an alternate to the Honey Brook Township Zoning Hearing Board for a three (3) year term commencing on January 7, 2019 and expiring on December 31, 2021.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the Pennsylvania Municipalities Planning Code, Section 903, the Board of Supervisors of Honey Brook Township hereby appoints two residents of Honey Brook Township to the Honey Brook Township Zoning Hearing Board for a three (3) year term commencing on January 7, 2019 and expiring on December 31, 2021.as follows:

David Rodgers as a member; and  
Darlene Olear as an alternate

FURTHER RESOLVED, that this Resolution shall take effect immediately, or as soon as legally permissible thereafter.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Honey Brook Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.


FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.



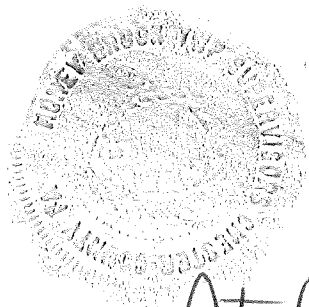


