John Goodall reviewed two new applications, totaling 170.6 acres. The committee reviewed the townships financial position and found it favorable to proceed.

There was a motion to recommend that the Honey Brook Township Supervisors support the purchase of easements for parcels 22-7-52, 22-7-7, 22-7-12, 22-7-47, and 22-7-48 for a total amount of not more than \$422,235 or not more than 45% of the appraised fair market value, estimated at \$5500 per acre.

Rob Daniels circulated a schedule of the update project. The committee considered adding an additional workshop meeting for Tuesday January 23rd, but has not confirmed. The committee reviewed the updated maps from the Conservancy and discussed criteria used to determine priority for approvals.
